If you earned less than \$48,000 in 2009, you can receive **FREE** tax preparation and may be eligible for an EITC (Earned Income Tax Credit) refund of up to \$5,657.

What do you bring?

- ✓ Valid picture ID
- ✓ ALL W2's + 1099's, New automobile purchase invoices, Unemployment
- ✓ Real estate tax receipts for rent/tax rebate
- ✓ Form 8332 required for non-custodial parents
- ✓ Social Security Numbers or ITIN for yourself and all dependents (e.g. spouse, children- please bring your children's social security cards with you)
- ✓ Completed W-7's as appropriate. (Application Tax Identification Number for individuals who are not U.S. citizens or permanent residents)
- ✓ Last year's return (optional, but very helpful)
- ✓ Any records relating to income & expenses (e.g. business, rental income, dividends, sale of stock: -you must bring information on the original cost of the stock)
- ✓ Personal bank account check
(if you would like direct deposit into your bank account)
