LOCATIONS THROUGHOUT LACKAWANNA AND WAYNE COUNTIES WILL BE OPEN FROM

MAKE SURE YOU BRING THESE DOCUMENTS WITH YOU TO HAVE YOUR TAXES PREPARED:

- Valid picture ID
- ALL W2's + 1099's, Unemployment
- Real estate tax receipts for rent/tax rebate
- Form 8332 required for non-custodial parents
- Social Security Numbers or ITIN for yourself and all dependents (e.g. spouse, children- please bring your children's social security cards with you)
- Completed W-7's as appropriate. (Application Tax Identification Number for individuals who are not U.S. citizens or permanent residents)
- Last year's return (optional, but very helpful)
- Any records relating to income & expenses (e.g. business, rental income, dividends, sale of stock: -you must bring information on the original cost of the stock)
- Personal bank account check (if you would like direct deposit into your bank account)
- Any documentation relating to your health insurance for the year! This could be Forms 1095-A, 1095-B, 1095-C, or a list of who on your tax return had health insurance coverage in 2017 and for which months they were covered. Any paperwork from the Health Care Marketplace must be brought as well!
